A Look at the Proposed Amendments to the Legal Practitioners Act.

The Legal Practitioners Act is now subject of review by the NBA. There have been a number of conflicting proposals before the National Assembly on key practical issues including required qualifications for both domestic and foreign legal professionals working in a jurisdiction; common legal professional structures; national regulators, legal professional insurance and client protection; confidentiality and legal professional privilege; legal fees and fee regulation; client money; and notaries.The National Assembly has now called on the legal profession and its regulatory affiliates to put its house in order to enable the enactment of the passage of a legislative framework that reflects the concerns of lawyers. This session will examine NBA proposals for the review of the Legal Practitioners Act.

Lawyers in the Spotlight: Essential Anti-Money Laundering Considerations for the Legal Profession.

The ICJ is the only international court that settles disputes between the 193 United Nations Member States. This means that it makes an important contribution to alobal peace and security, providing a way for countries to resolve issues without resorting to conflict. Questions have been raised about the effectiveness of this body especially as it concerns the binding effect of its advisory opinions. Panelists at this session will include lawyers from the South African legal team sharing their experience with an array of international law practitioners on the relevance of the ICJ in an increasing divided world in need of an effective dispute resolution institution.

The enactment of Companies and Allied Matters Act, 2020 (CAMA) was seen as one of the most consequential interventions in the corporate and business regime in Nigeria. Its objective was to remove regulatory hurdles that have continuously beleaguered the smooth conduct of business activities alongside increase investor confidence in Nigeria and promoting the ease of doing business in Nigeria. It has now been four years since the enactment of the Act, what has been its impact on corporate governance? Has the Act supported the strengthening, deepening, widening and or improvement of the business environment in Nigeria including the accumulation of desperately needed capital required to; reflate our economy, enhance company investments, and build needed infrastructure? These are the questions the panelists at this session will seek to discuss.





BREAKOUT SESSION VII

Conflicting Decisions, Knowingly Made: Endangering the Rule of Law and Economic Growth. Conference Arena, Tafawa Balewa Square

The incident of conflicting judicial decisions is sometimes unavoidable due to the dynamics and the breadth of our legal system. However, there is a recent spate of conflicting decisions of an inexcusable specie that have gained notoriety and have increasingly become an embarrassment to the Bar and the Bench. These occur where litigants who are parties in litigation against whom an adverse decision has been made, knowingly go before another court of coordinate jurisdiction to secure a contrary and conflicting decision. While there is broad consensus that these developments constitute a danger to the rule of law and Nigeria's economic development, the Bar and the Bench are not doing enough to deter this phenomenon by enforcing relevant regulatory sanctions. should respond.

BREAKOUT SESSION X

Traditional Rulers Roundtable: Proposals for Integrating Traditional with the Contemporary in Justice Delivery.

Conference Arena, Tafawa Balewa Square

Concern about the efficacy of the formal Administration of Justice system has led to increasing attention being paid to traditional justice systems. Nonetheless, despite the rhetorical acknowledgement of the importance of traditional and informal justice systems, the biggest challenge to a balanced and well-informed appreciation of traditional/informal justice systems is the existence of a knowledge gap. Consequently, the national discussion on this issue is largely based on weak data, ex ante evaluation and speculation. This session will discuss the framework of the traditional justice methods in several Nigerian ethnic groups with a focus on the role of traditional courts or the forum of elders, the methods of settlement of disputes including the practices, customs and traditions of the people that were devised as ways of maintaining peace and tranquility. Panelists will also examine whether there exist opportunities for the convergence of the traditional and contemporary justice system.

BREAKOUT SESSION XI

Special Interest Session / Nigerian Army / Nigerian Air Force / Nigerian Navy/ Nigeria Police/ Nigerian Correctional Services -Are We Winning the War Against Insecurity?

This is a special interest group session of security agencies in Nigeria. Nigeria is presently bedeviled by an abundance of security challenges that constitutes a threat to the nation's existence. The prevalence of insecurity in the country is multipronged and comprises insurgency, killer herdsmen, extrajudicial killings, ethno-religious conflict, armed robbery, militancy, banditry, cybercrime and attacks by unknown gunmen, among other things. There is a compelling need to address the protracted and recurring multidimensional insecurity in Nigeria. BREAKOUT SESSION 1

Symposium: Globalisation of the Legal Profession

The recent United Kingdom and Nigeria Enhanced Trade Investment Partnership Agreement signed in February 2024 generated much furore within the legal profession particularly with respect to the agreement on the provision of legal services. The very idea of allowing foreign law firm access to the Nigerian legal market unsettled many practitioners, especially as most local Nigerian firms do not have access to the British legal market. The current reality is that economic globalisation is shaping the present and the future of legal practice in Nigeria. This session will provide participants with an opportunity to reflect upon-rather than merely react to-globalisation with a view to thinking about globalisation both offensively and defensively considering both the opportunities and challenges globalisation presents.

BREAKOUT SESSION II

From Crisis to Action: Is the tide rising against Gender-Based Violence?

Gender-based violence (GBV) is one of the most widespread human rights abuses in the world, affecting individuals and impacting entire communities. In Nigeria, it is driven by gender inequality and can take many forms, including intimate partner violence; sexual violence and harassment; child, early, and forced marriage; and other manifestations of violence that are rooted in abuse of power and harmful norms. This session will evaluate the adequacy of legislative and institutional response to GBV in Nigeria, side by side with an appreciation of experiences from other countries with a view to addressing gender-based violence has a critical area of intervention that must continue to be elevated as a prominent issue of national discuss.

Navigating Legal Currents: Understanding Recent Developments in Shipping and Admiralty Law and Their Relevance to General Commercial Practice.

Nigeria has a vested interest in ensuring the safety, security, and sustainability of its maritime trade, activities, and the environment. Recent developments in Nigeria's admiralty laws have sought to enhance the legal framework governing maritime matters and promote its position as a key player in the maritime industry, while at the same time, reflecting Nigeria's commitment to upholding maritime safety, security, and environmental sustainability. This session will review some of the most important legal developments in maritime law including the law of shipping contracts, marine insurance, seafarers' rights and admiralty issues. There will also be a discussion on the effects of these developments on Nigeria's blue economy.





BREAKOUT SESSION IV

Exploring Contemporary issues in Administration of Criminal Justice: Perspectives and Insights. Conference Arena, Tafawa Balewa Square

In recent years, Nigeria has witnessed significant developments in its criminal justice landscape in addressing emerging challenges. Some notable developments include the enactment of Administration of Criminal Justice Laws in several states, the Correctional Services Act, updated practice directions to provide judges with more discretion in adjudication and case management. However, challenges persist in the Criminal Justice System. Issues such as delays in trials, access to legal representation, and overcrowding in correctional facilities, require ongoing attention and reforms. This session will examine the adequacy of existing laws and other institutional reform initiatives at the Federal and State levels while proffering practical measures for achieving sustainable reforms in our criminal justice system.

BREAKOUT SESSION V

Nigeria Governors' Forum on Judicial Infrastructure.

The Nigeria Governors Forum (NGF) is an important platform of collaboration between states irrespective of party differences and economic strength. One of the issues that the NBA has engaged the NGF, is the need for a holistic improvement in judicial infrastructure in the states. In particular, the poor funding and limited attention paid to magistrates' courts and similar courts of coordinate jurisdiction is a matter of much concern. This is more so when it is realized that these courts deal with the bulk of citizens' matters. 




